# HOPEWELL AREA SCHOOL BOARD REGULAR WORK MEETING FEBRUARY 12, 2013

The Board of Directors of the Hopewell Area School District met in regular session on Tuesday, February 12, 2013, in the Board Room, Administration Building, 2354 Brodhead Road, Hopewell Township.

The meeting was called to order at 7:04 p.m. by David Bufalini, Board President.

At this time Dr. Reina discussed his ongoing conversations with Hopewell Township Commissioners and retired law enforcement officers regarding the potential partnership between the Township and the District with respect to school security. Dr. Reina continues to explore options to make our buildings safer and to develop a training program for staff. The Board expressed a desire to have a police presence on a regular basis within the District as soon as possible.

Capital projects were also a topic for discussion. Dr. Reina would like to begin making plans for those projects the Board would like to undertake during the coming months. Options included: the pool, tennis courts, High School Maintenance/Cafeteria Court area, Central Administration furniture and the basketball court in the back of the Junior High School. Dr. Reina said that a proposal would be made in March regarding the technology initiative. Several Board members expressed a desire to refurbish the basketball court at the Junior High School. As Mrs. Robb continues to develop the 2013-2014 budget, discussions regarding capital projects will continue.
