The Board of Directors of the Hopewell Area School District met in regular session on Tuesday, December 1, 2015 in the Board Room of the Administration Building, 2354 Brodhead Road, Hopewell Township for the purpose of effecting a permanent organization of the Board in compliance with Section 404 of the Public School Code of 1949, as amended, and any other business which may come before the Board of Directors.

There being no other nominations for Vice President, Motion by John Bowden, seconded by Daniel Santia nominations for Vice President closed.

Roll call vote for Lesia Dobo as Vice President of the Board of Directors. Motion carried unanimously by an affirmative roll call vote of all Directors present.
