## Golden Rule: Treat others as you would treat yourself Classroom Rules

1. Respect every person, their property, and the property of the school.

Positive Notes or Phone Calls Home (Weekly)  
Various Other Perks (throughout the school year)  
The Joy of Learning (everyday)

### **If You Chose to Break a Rule**

Examples of consequences (ideally the consequence will be related to the misdemeanor, or broken rule):  
Staying after school  
TLC  
Classroom Community Service (i.e. sweeping the classroom after school)

**Students:** I have read this classroom discipline plan and understand it. I will honor it while in Room 122.

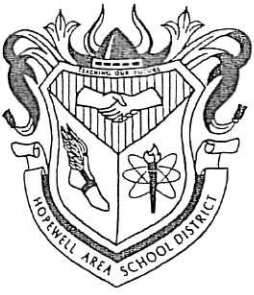

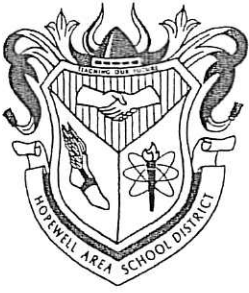
